



## Aquatic Facility Plan

*Per Burlington County Bathing Code Subchapter 5.10(d)*

### Hours of Operation

- Braddocks Mill Lake is open Memorial Day to Labor Day, Dawn to Dusk.
- Use of the beach is for members of Braddock's Mill Lake and their guests.
- Members must be current in their dues to enjoy the benefit of beach access.
  - The beach gate and the first aid shed have a combination lock. The code is provided to members current in their dues. The gate should remain locked at all times, after entering and leaving. The shed can remain open during your visit and locked upon leaving.

- Guests of members should be accompanied by a member when at the beach.
- Parking is not permitted outside the gate.

### Map and Bathing Beach Rules

- The swimming area is designated by buoys and a floating dock and will be maintained in a clean and safe condition, free from rocks and holes.
- No Diving is permitted.
- No Lifeguard is on duty. Children must be accompanied by an adult. Swim at your own risk.
- No large holes may be dug at the beach; there is no wave action to refill holes.
- Dogs brought to the beach must be kept under control and cleaned up after.
- No smoking and no fishing within 25 feet the beach swimming area.
- Glass bottles and not permitted at the beach.
- The beach is strictly car-in carry-out and trash free. All trash and debris must be removed by the member who brings it to the beach.
- Parties and large gatherings cannot be held at the beach without prior approval of the President or Chairperson of the Lake Committee at least two weeks prior. Parking is limited at the beach.

### Evacuation Plan for Bathing Beach

- The BMCA has bacteriological beach and natural bathing water analysis performed weekly during the open season. In the event of an Unsatisfactory beach water analysis result, a sign will be posted at the beach.

### First Aid Kit and Rescue Equipment

A 18" ring buoy is located along the beach area.

The following safety equipment is located in the shed:

- a reach pole measuring at least 12 feet with blunt ends
- a full spine board complete with ties, head restraints
- a first aid kit

A telephone for emergency use with direct contact to emergency services is located behind the shed.

5. Weekly Beach Water Analysis Report
6. Weekly Playground Inspection Record
